The Tax Manager will provide broad tax support across the BHC product companies in the Caribbean region, but primarily in Guyana, Trinidad and Surinam. This role will work closely with the operations team as well as with the corporate tax team. Primary responsibilities will include assistance in developing and managing local tax strategy positions and compliance status with tax authorities, managing various tax audits, coordinating with multiple teams such as commercial tax, planning, transfer pricing, indirect taxes, employment tax experts and tax compliance – both locally and to feed into US GAAP reporting work streams. This role will routinely work with sales and commercial teams, treasury, mobilisation experts, legal and finance, in order to drive customer outcomes. This person will also co-ordinate with external tax advisers, legal firms and tax authorities.
