



Request for Information (EFI)

Baker Hughes is an energy technology company with a diversified portfolio of technologies and services that span the energy and industrial value chain. We conduct business in more than 120 countries.

Believes that its principal competitive factors in the industries and markets it serves are product and service quality, efficiency, reliability and availability, HSE standards, technical proficiency, and price.

While Baker Hughes may have contracts that include multiple well projects and that may extend over a period of time ranging from two to four years, its services and products are generally provided on a well-by-well basis. We are inviting companies to submit an Information for the upcoming opportunities in the area(s), as listed below. The supply/service(s) would be performed in Guyana to support our in-country operations.

The Opportunity

Baker Hughes has extensive facilities in Land of Canaan, Guyana known as the Baker Hughes Guyana Supercenter. When the Supercenter opens in Q1 of 2022 it will act as the backbone for our Guyanese Operations and serve as a base for wider Caribbean operations, including those in Suriname, Trinidad & Tobago and further afield.

In keeping with our strategy of working with "local content" where possible to develop and grow our business, we are seeking a partner to provide Security Services, managed to Baker Hughes.

The scope of Security Services we seek are:

- The Contractor shall furnish the Services to the Client and shall assure the safety of the Client's buildings, grounds and premises, personal property and personnel and customers of the Client and within the total required daily security officer man/hours which the Contractor has determined are necessary to adequately perform the Services.
- The Contractor shall provide all necessary management oversight; training; supervision; manpower; uniforms; batons, and replacement or substitute manpower to always maintain full Services.
- A Client Service Representative of the Contractor shall be available to consult with the Client daily between the hours of 9.00 a.m. and 5.00 p.m. In the event that the Client for whatsoever reason requests another person as the Client Service Representative, the Contractor shall immediately designate another person to act in that position with the concurrence of the Client.
- In the event of an Emergency the Client may contact any of the authorised representatives of the Contractor.
- Throughout the duration of this Contract the Contractor shall also provide and maintain as a minimum the insurance coverage.

- The daily security protection services referenced above shall be provided during the hours specified (4 officers during the daytime, 3 Officers at night). The Parties may vary these hours if mutually agreeable, and the Contractor reserves the right to modify coverage requirements without amending this Contract so long as coverage requirements do not exceed the total weekly hours agreed. In addition, if the total hours required by the Client in any week exceeds the total weekly hours agreed those additional hours are to be billed under the standard rate.
- The Contractor shall be licensed as a qualified security services company in accordance with the requirements of the laws of Guyana and must maintain such licensing throughout the term of this Contract. The Contractor shall comply with all applicable laws in obtaining any necessary permits and licenses. In the event that the Contractor should cease to be licensed the Client may terminate this Contract with immediate effect.

RFI Requirements

We require that any potential partners and those considering responding to this Request for Information of Interest have the following:

Interested companies are required to:

- Registered with the Centre for Local Business Development (CLBD) in Guyana
- Submit a company profile inclusive of full contact details, physical address, Tax Identification No. (TIN), VAT, details on any joint ventures, partnerships, etc. that are part of your organization's structure.
- Demonstrate your capabilities through your work experience for providing services
- Locally owned company will be an asset.
